Laguna Resorts & Hotels Public Company Limited, formerly named Thai Wah Resorts Development Company Limited, was founded in 1983. It shortly thereafter acquired a large parcel of land on the site of an abandoned tin mine at Bangtao Bay, Phuket, Thailand which was later developed to become the Laguna Phuket integrated resort complex. The company was listed on the Stock Exchange of Thailand in 1993 and in May 1998 the company's name was changed to Laguna Resorts & Hotels Public Company Limited to better reflect its core business operation.

Banyan Tree Holdings Limited is the largest shareholder in Laguna Resorts & Hotels Public Company Limited, controlling 54.8% of total shares. Mr. Ho Kwon Ping, Executive Chairman of Banyan Tree Holdings Limited is also Chairman of Laguna Resorts & Hotels Public Company Limited.

Laguna Resorts & Hotels Public Company Limited has gained the reputation as a responsible developer whose interests combine hotels and real estate with an emphasis on quality and environmental protection. In addition to its core hotel business at Laguna Phuket, the company has successfully diversified into overseas properties, vacation ownerships, corporate training, managing a shopping centre, wedding chapel and a tour operation, all of which support and strengthen the operations of its established resorts.
